WARRANTY APPLICABLE IN THE UNITED STATES TO PRODUCTS SOLD THROUGH AUTHORIZED MAIBEC RETAILERS.

### **DURATION AND SCOPE OF WARRANTY**

Under the terms and conditions of this warranty, Maibec Inc. warrants the Natural Tonest stain on the product (two (2) color factory coats) against peeling, blistering and cracking due to normal weathering for a period of **eight (8) years or six (6) years** in Coastal regions<sup>t†</sup> from the date of purchase.

- A.For the first three (3) years after the purchase date, Maibec Inc., at its sole discretion, shall reimburse either the purchaser or subsequent owner of the building, as the case may be, for the cost of a sufficient amount of stain and the labor if needed to retouch the damaged surfaces, or shall supply the necessary stain and labor.
- B. During the five (5) remaining years of the warranty (three (3) in Coastal regions), Maibec Inc., at its sole discretion, shall only supply a sufficient amount of stain to retouch the damaged surfaces.

This warranty specifically excludes any other damage, of whatever nature, including the cost of labor if needed (except what is provided for the first three (3) years of warranty as mentioned above) installation or reinstallation costs and other direct or indirect damage, real or anticipated, present or future.

By purchasing the product, the purchaser accepts the terms and conditions of this warranty, which replaces any other representation, warranty or condition, explicit or implicit, statutory or other. The terms of this warranty are automatically transferable to the subsequent purchaser of the residential or commercial building upon which the product has been installed.

### **CONDITIONS OF THIS WARRANTY**

- A. This Limited Natural Tonest Stain Warranty is conditional upon compliance with Maibec installation requirements\*, proper and regular maintenance\*\* and building codes applicable in your region. Failure to comply with these requirements and codes will void the warranty. The installation requirements can be found in the product bundle. They are also available on maibec.com.
- B. This Limited Natural Tones† Stain Warranty is also conditional on compliance with the written notice and claim requirements set forth below and Maibec performing an inspection prior to any repairs being made to confirm that the product shows one of the defects covered by this warranty. Failure to comply with these requirements will void the warranty.

### **EXCLUSIONS**

- A. If a product is found to be unsatisfactory prior to installation, for whatever reason, it must not be installed and Maibec must be contacted immediately. Installation of the product constitutes full and complete acceptance by the client and Maibec Inc. will not be held liable, in any way, for labor or material if a defective or non-standard product is installed. Maibec Inc. shall not be liable for any consequential or special damages, or for other expenses (material, labor or any other expenses) which may arise in connection with this warranty.
- B. This warranty shall be void if the product is immersed in water or comes into direct contact with the ground or adjacent horizontal structures, including house boat and boat house.

- C. This warranty does not cover any other damages other than those previously noted such as, but not limited to, defects due to (a) improper handling, faulty installation, improper drainage, improper storage or defective building design; (b) repairs and/or altering of the product; (c) touch-up misapplication; (d) movement of the structure to which the product is installed; (e) wear and abrasion caused by the combined effects of the wind and salt air, the wind and sand or the wind and snow/ice; (f) acts of God such as, but not limited to, hurricanes, tornadoes, floods, earthquakes, and sleet and hail; (g) growth of mold and/or mildews and/or stains caused by bleeding or other extractives from wood or any other biological agent on any surface of the product.
- D. Fading and discoloration caused by normal wear and exposure to the elements are naturally occurring phenomena and do not constitute a product defect, and therefore are not covered by this Limited Natural Tones<sup>†</sup> Stain Warranty.
- E. Siding is for vertical installation only. Siding installed to nonvertical surfaces such as sloping or angled walls are not covered by any warranty
- F. Due to the particular weather conditions in the Great North (north of the 55<sup>th</sup> parallel), this warranty does not apply in those regions. Maibec offers a selection of siding and moldings approved for the Great North (north of the 55<sup>th</sup> parallel). A specific warranty applies to these products. Contact Maibec for details.

#### SUBMITTING A CLAIM

- A. The covered person must contact Maibec Inc. within thirty (30) days following the discovery of any product failure or defect covered by this warranty. The claimant is responsible for providing the information and supporting documents needed by Maibec Inc. to investigate the claim.
- B. Any claim under this warranty by the purchaser or subsequent owner, as the case may be, must be made in writing during the period covered by the warranty and must include the original invoice from the authorized retailer of the Maibec siding product.
- C. Upon reasonable notice, the purchaser or owner must allow Maibec's agents to enter the property and structure on which the product(s) is applied to inspect such product(s). For the avoidance of any doubt, such an inspection may require the removal of some of the product from the structure to which it has been installed.
- D. Any settlement between Maibec Inc. and the covered person regarding the refund, material replacement or corrective action constitutes a full settlement and release of all claims relating to this warranty.
- E. In the event that the claimed product is no longer offered, Maibec reserves the right to provide another product of equivalent value.
